A BILL

To amend the America’s Water Infrastructure Act of 2018 to expand the Indian reservation drinking water program, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Western Tribal Water
5 Infrastructure Act of 2021”.

6 **SEC. 2. INDIAN RESERVATION DRINKING WATER PROGRAM.**

7 Section 2001 of the America’s Water Infrastructure
8 Act of 2018 (42 U.S.C. 300j–3e note; Public Law 115–
9 270) is amended—

1 (1) in subsection (a)—

2 (A) in the matter preceding paragraph (1),
3 by striking “Subject to the availability of appro-
4 priations, the Administrator” and inserting
5 “The Administrator”;

6 (B) in paragraph (1), by striking “and” at
7 the end;

8 (C) in paragraph (2), by striking the pe-
9 riod at the end and inserting “; and”; and

10 (D) by adding at the end the following:

11 “(3) 10 eligible projects described in subsection
12 (b) that are within—

13 “(A) the Columbia River Basin; or

14 “(B) a coastal basin adjacent to the Co-
15 lumbia River.”;

16 (2) in subsection (b)(1)—

17 (A) by striking “is on a reservation” and
18 inserting the following: “is on—

19 “(A) a reservation”;

20 (B) in subparagraph (A) (as so des-
21 ignated), by striking “and” at the end and in-
22 sserting “or”; and

23 (C) by adding at the end the following:

1 “(B) an off-reservation site that serves an
2 Indian Tribe described in subsection (c)(2)(B);
3 and”;

4 (3) in subsection (c)—

5 (A) by striking the subsection designation
6 and heading and all that follows through “In
7 carrying out” and inserting the following:

8 “(c) REQUIREMENTS.—

9 “(1) UPPER MISSOURI RIVER BASIN.—In car-
10 rying out”; and

11 (B) by adding at the end the following:

12 “(2) COLUMBIA RIVER BASIN.—In carrying out
13 the program under subsection (a)(3), the Adminis-
14 trator of the Environmental Protection Agency
15 shall—

16 “(A) give priority to projects that respond
17 to emergency situations where a lack of access
18 to clean drinking water threatens the health of
19 Tribal populations;

20 “(B) select not fewer than 1 eligible
21 project that serves 1 or more Tribal commu-
22 nities of federally recognized Indian Tribes the
23 Federal recognition of which has been termi-
24 nated and subsequently restored; and

1 “(C) ensure that not fewer than 1 eligible
2 project under that subsection is carried out
3 in—

4 “(i) the area described in subpara-
5 graph (A) of that subsection; and

6 “(ii) an area described in subpara-
7 graph (B) of that subsection.”;

8 (4) by redesignating subsection (d) as sub-
9 section (e);

10 (5) by inserting after subsection (c) the fol-
11 lowing:

12 “(d) FEDERAL SHARE.—The Federal share of a
13 project carried out under this section shall be 100 per-
14 cent.”; and

15 (6) in subsection (e) (as so redesignated), by
16 striking “\$20,000,000 for each of fiscal years 2019
17 through 2022” and inserting “\$50,000,000 for each
18 of fiscal years 2021 through 2024”.
